Invoices submitted must clearly show a dealer name, date of purchase, quantity purchased and description of items purchased. We will not accept packing slips; pick tickets, sales reports, sales quotes or credit memos as proof of purchase. Order acknowledgements/confirmations are acceptable as long contractor provides a proof of purchase. The program will expire on December 31 2021. Contractors can submit invoices until 11:59 PM on January 31 2022.



Receive your reward

Gift cards are the form of payment. Administrative fees may apply against payment remittance in case of lost or stolen card. Maibec reserves the right to delay payment for reason beyond its control.

Maibec will issue a Visa® Prepaid Card during the month following reception of all qualified invoices. If you currently have a card, please use current funds before discarding, as funds will not roll over to your new card.

You may be required to produce a W9 form so Maibec may issue a 1099-MISC Form in order for you to declare the received payments. Maibec is issuing the cards under the company name at the attention of the submitter's attention.
